



PROTOCOL ON INTERNATIONAL EDUCATIONAL COOPERATION between

YILDIZ TECHNICAL UNIVERSITY Istanbul, Republic of Turkey and UNIVERSITY OF COLOMBO Colombo, Sri Lanka

This memorandum of understanding (herein after referred to as MOU) is made and entered in to in Istanbul on this 05th day of June Two Thousand and Fourteen

between

University of Colombo (herein after referred to as UOC) established by the Universities Act Nr 16 of 1978 of the Democratic Socialist Republic of Sri Lanka, and situated at Nr 94, Cumarathunga Munidasa Mawatha, Colombo 03, Sri Lanka

and

Yildiz Technical University (herein after referred to as YTU) founded in 1911, and situated at Barbaros Bulvarı, 34349 Yıldız, Istanbul, Republic of Turkey

wishing to establish the cooperative relations between the two universities, especially to develop academic and cultural interchange between the two institutions in education, research, and other areas, agree to the following provisions.

Objectives

In order to promote further the existing cultural and educational cooperation between Turkey and Sri Lanka, University of Colombo (UOC) and Yıldız Technical University (YTU) join in the following protocol on educational and scientific cooperation.

The two universities will endeavor to cooperate in education and research in areas of mutual interest. To the extent feasible, both universities will encourage direct contact and cooperation between faculty members, Institutes, campuses and students.

AREAS OF COOPERATION

Specific areas of cooperation between the two universities may include, but are not limited to, the following:

- 1. Exchange of faculty
- 2. Exchange of students
- 3. Joint research and development (R&D) work
- 4. Participation in seminars & academic meetings, and online learning programs
- 5. Exchange of published academic materials and other information
- 6. Special short-term academic programs.

1.1 EXCHANGE OF FACULTY

- 1.1.1 Although travel expenses and living costs of exchange faculty and research scholars are not compensated by the host institution, in case additional financial support is needed it will be evaluated on an individual basis.
- 1.1.2 The host institution shall provide work space and give access to libraries, laboratories and other facilities to exchange faculty and research scholars.
- 1.1.3 Unless otherwise agreed upon, all exchanges are on the basis of reciprocity.
- 1.1.4 Faculty/ scholar exchanges will normally be for the duration of one or two semesters, shorter or longer stays are possible, subject to mutual agreement.
- 1.1.5 Faculty/ scholar exchanges remain subject to the approval of the host institution.
- 1.1.6 Each professor/ scholar remains on salary with the home institution during the exchange, and remuneration for special projects is subject to special negotiation.
- 1.1.7 Visiting professor/ scholar must carry medical health insurance in accordance with the rules and regulations of the host institutions and/ or the host government.
- 1.1.8 Teaching course loads and working hours and conditions shall normally be in accordance with established rules and practices of the host institution, subject to prior negotiation and agreement.
- 1.1.9 The Protocol between UOC and YTU may be in any appropriate academic field at either institution, subject to the prior approval of the administration of the host institution.

1.2 EXCHANGE OF STUDENTS

- 1.2.1 Such applications are honored by UOC and YTU on the principle of reciprocity.
- 1.2.2 Exchange students shall be admitted as non-degree students for a period of one or two terms (fall or spring), or for both semesters, and for a maximum of one academic year.
- 1.2.3 Exchange students may take courses for credit, and the host institution shall issue a transcript and grades for exchange students under the same rules and regulations as for its degree-seeking students.
- 1.2.4 So long as the principle of reciprocity is maintained, tuition and fees shall be waived for exchange students by the host institution.
- 1.2.5 Exchange students shall be recommended by the sending institution and follow established rules and procedures set forth by the host institution.
- 1.2.6 Travel and living expenses for exchange students are borne by the students themselves, by a sponsor, or by the sending institution.
- 1.2.7 Students coming to YTU are required to get the proper visas prior to coming to Turkey so that it will be possible to acquire the Long Term Residence Permit in Istanbul. Students selected to UOC are required to get relevant visa in advance.
- 1.2.8 An affidavit of Financial Support (AFS) for living expenses must be submitted in advance to the host institution by the exchange student(s).



RENEWAL, TERMINATION AND AMENDMENT

- 1. These regulations are to be authorized by the official representative of both universities in two copies, and each party will retain one.
- 2. Except where specified and agreed upon, this Protocol will impose no financial obligation on the host institution.
- 3. The two institutions will evaluate each application in accordance with items pertaining to the implementation of the exchange programs based on this Protocol.
- 4. The period of validity of this Protocol is for five (5) years. Thereafter, it is renewed yearly, unless either side provides a six-month notice of intent to terminate. This Protocol will become effective at the time it is signed by the authorized representatives of both institutions.

Items not covered by the Protocol may be determined and negotiated separately by both institutions without abrogating this Protocol; the Protocol may be amended with the consent of both parties.

MISCELLANEOUS

- 1. This Protocol shall be carried out subject to availability of funds and written approval of both parties.
- 2. This Protocol is not intended to be legally binding but simply expresses the intentions and understandings of the parties. It shall, however, form the basis of a specific project agreement to be drafted and executed in the future.
- 3. Any difference or disputes between the parties concerning the interpretation or implementation or application of any of the provisions of this Protocol shall be settled amicably through mutual consultation or negotiations.

This Protocol is signed in English, in the city of Istanbul, Republic of Turkey and in the city of Istanbul and all of them having the same legal validity; notwithstanding, in case of a discrepancy or difference in interpretation between the English original and the Turkish/ Sinhala/ Tamil translations, the English shall prevail. Upon the approval of the partner university by the Turkish Council of Higher Education/ University Grants Commission (UGC) Sri Lanka, this protocol will be valid.
