

**MEMORANDUM OF UNDERSTANDING**

**Between**

**YILDIZ TECHNICAL UNIVERSITY, TÜRKİYE**

**And**

**HANBAT NATIONAL UNIVERSITY, SOUTH KOREA**

**For**

**THE ESTABLISHMENT OF A COOPERATIVE PROGRAM OF ACADEMIC AND SCIENTIFIC EXCHANGE**

THIS AGREEMENT is entered into between Hanbat National University, herein after referred to as HBNU, South Korea and Yildiz Technical University, herein after referred to as YTU.

WHEREAS,

- HBNU and the YTU, hereafter referred to as the Participants, recognize a mutual interest in research programs in the fields of printed electronics, materials science, and other fields as agreed.
- The Participants believe that expanded scientific collaboration and exchange of staff and students will be of mutual benefit.

THEREFORE, the Participants have reached the following understandings:

**1. Promotion of Joint Research**

The Participants may establish opportunities for mutually beneficial joint research and development. When such opportunities are recognized, the participants should document the errands to be undertaken, the role of each Participant including the relevant terms and conditions.

**2. Exchange of Graduate Students and Technical/Academic Personnel**

Both Participants may exchange graduate students and technical/academic personnel working in the areas of mutual interest. Such exchanges may be subject to a written agreement between the Participants identifying the terms and conditions of exchange, including financial arrangements and intellectual property considerations.

**3. Organizing International Conferences and Workshops**

The Participants may organize periodic workshops and international conferences to keep up with the recent trends and research developments in the mutual fields of interest and to recognize each other's research activities. The Participants may also coordinate periodic reviews of the research activities pursuant to this Memorandum of Understanding to ensure it is meeting its

intended objectives.

#### 4. Financial Considerations

Each participant should bear the expense of its participation and its personnel in cooperative activities under this Memorandum of Understanding, unless agreed in writing.

#### 5. Entry into Operation and Amendment

Cooperation under this Memorandum of Understanding commences upon signature of both the Participants and extends for a period of 5 years. It may be amended or extended by written agreement of the participants.

#### 7. Legal Status

This Memorandum of Understanding is not intended to create binding legal obligations.

#### 6. Disputes

Any questions of interpretation and implementation relating to this Memorandum of Understanding during its term should be resolved by the agreement of the Participants.


