



Memorandum of Understanding

This document represents an agreement between

Széchenyi István University, Hungary

and

Yıldız Technical University, Türkiye

Objectives

This Memorandum of Understanding aims to establish a spirit of cooperation in pursuing educational, research and training opportunities between **Széchenyi István University Győr**, **Hungary** and **Yıldız Technical University**, **Türkiye** in order to foster the development of the parties via collaborative endeavors.

The nature of the collaboration

It is based on mutual consent of the Parties to strive:

- to shape reciprocal understanding of the two institutions and promote on-going relationship and cooperation in areas of talent fostering, the development of educational, teaching and management systems with the help of bilateral academic exchanges in order to achieve improvement in the level of education and teaching on both sides,
- 2. to develop a spirit of cooperation by short-term study abroad program, teacher exchanges, cultural exchanges and leadership visits by both Parties when opportunities arise,
- 3. to explore opportunities to share teaching resources and materials.

Additional Information

- The operational details of any specific project under the scope of this Memorandum of Understanding may be governed by terms and conditions to be separately negotiated and mutually agreed upon by both Parties through an exchange of letters or the signing of a subsidiary joint agreement.
- 2. The parties signing the agreement commit to organizing teacher exchange for (1) one or (2) two academic semesters. Both partners must have the same number of exchange teachers. The exchange takes place only if and to the extent that both parties send teachers to the other institutions. There must also be full parity in terms of the timing (concurrent incoming and outgoing exchanges), and the length of the exchange period.
- The partner institution that sends teachers must submit the names of candidates suitable for the exchange. Candidates must fulfil the requirements of registration at the host institution.
- 4. Their mastery of the language of the host country or English should be sufficient to meet the objectives of the exchange to obtain the expected benefits from it, depending on the activity to be developed. Exchange teachers will not pay any academic or enrollment fees to the host University but should assume any cost related to eventual academic travels or field trips additional to their main activity during their mobility period, and they must cover all the costs related to air tickets, living and international health insurance. No financial commitment on the part of any of the institutions is foreseen or implied in this Agreement.
- 5. The Parties consent to sign specific agreements for specific projects after full consultations.
- 6. It is being acknowledged by the Parties that the establishment of the cooperation between Széchenyi István University Győr, Hungary and Yıldız Technical University, Türkiye to enhance the internationalization process and strengthen international research, together with academic, scientific, educational and cultural cooperation of Hungarian and Turkish higher educational institutions.

7. The parties undertake to maintain confidentiality regarding the information exchanged. generated or pre-existing to this instrument, and its disclosure to third parties, directly or indirectly, without prior written authorization from the other parties is prohibited. The obligation of secrecy remains in force for a period of 5 (five) years from the date of signature of this instrument.

This Memorandum of Understanding will become effective on the day of signing and remain in place for a period of 5 (five) years. Any amendment may be proposed through mutual consent and through obtaining the signatures of the legal representative on an Appendix attached to this Memorandum of Understanding.

The original text of this Memorandum of Understanding was formulated in English. Any translation of the text into another language shall be deemed as for reference only and the English version shall prevail as the legally binding version.

Each Party will hold two original copies of the Agreement.
